

## Rules

### I. General Information

Blood Bank of San Bernardino and Riverside Counties ("LifeStream"), a tax-exempt organization under Section 501(c)(3) of the Internal Revenue Code, is conducting this raffle pursuant to California Penal Code Section 320.5, et seq., to raise funds for ongoing charitable purposes. The Rules and Regulations of The LifeStream Dream Raffle are set forth below. By purchasing a raffle ticket or tickets, the purchaser agrees to be bound by these rules and regulations. LifeStream's interpretation and application of the rules and regulations shall be final.

The Grand Prize is the winner's choice of (a) 2023 Ford Bronco Sport Base model factory equipped valued at \$32,000 or (b) \$25,000 cash (see Section VII below).

All raffle tickets will be included in the drawing for the Grand Prize and the other raffle prizes. No more than 1,000 raffle tickets will be sold. There is no guaranty that purchaser will win any prize, the odds of winning being dependent upon the number of raffle tickets sold (see Section V below). The sale of raffle tickets to the general public will commence on August 1, 2023 at 8:00 am Pacific Time and end at 11:59 p.m. Pacific Time on October 31, 2023. Tickets may be sold out before that time. In the event that LifeStream receives any request to purchase tickets after all 1,000 have been sold, or after 11:59 p.m. Pacific Time on October 31, 2023, LifeStream will return such request and any payment accompanying therewith.

The raffle drawing will take place on November 11, 2023, subject to rescheduling, as more particularly described below. The drawing will take place at LifeStream's Thanks4Giving Gala on November 11, 2023 at the Westin Mission Hills Resort in Rancho Mirage, California or at LifeStream's offices at 384 West Orange Show Road, San Bernardino, CA 92408. The drawing location may be changed without notice at LifeStream's discretion.

An independent auditor will supervise the drawings. Winners need not be present to win a prize in any drawing.

**The IRS has taken the position that amounts paid for chances in raffles, lotteries or similar drawings for valuable prizes are not gifts, and consequently do not qualify as deductible charitable contributions.**

## **II. Raffle Tickets**

Individual tickets may be purchased for \$100 each. Only one method of payment, one name, and one mailing address are permitted per raffle ticket transaction. Only one eligible person may be entered in the raffle per ticket transaction. If the name of more than one person is submitted with a ticket transaction, and the raffle ticket is selected as a winning ticket, then the person named first will be deemed the holder of record of that ticket and declared the winner. Division of any prize by a group purchasing a raffle ticket in common shall be the sole responsibility of the person named as the holder of record of that raffle ticket, should that raffle ticket be selected as a winner, and at no time shall LifeStream be obligated to split any prize among group members.

LifeStream reserves the right to reject any entry form that is submitted with payment that does not constitute "good funds" or contains any other missing information. All defective or physically altered entry forms will be immediately disqualified by LifeStream. Prior to the drawing, LifeStream will make a reasonable effort to notify any individual who submits a rejected entry form or one that has been rejected because the credit card or check did not clear. LifeStream will attempt to make contact through the information provided on the entry form at the time of submitting the purchase request. LifeStream assumes no responsibility for lost, late, misdirected or non-delivered packages or fax messages, or any other failure to receive orders or deliver receipts prior to the drawing deadlines.

**SHALL LIFESTREAM, ITS DIRECTORS, OFFICERS, EMPLOYEES, AGENTS OR REPRESENTATIVES BE LIABLE TO ANY PARTY FOR ANY LOSS OR INJURIES TO EARNINGS, PROFITS OR GOODWILL, OR FOR ANY INCIDENTAL, SPECIAL, PUNITIVE OR CONSEQUENTIAL DAMAGES OF ANY PERSON OR ENTITY WHETHER ARISING IN CONTRACT, TORT OR OTHERWISE, EVEN IF ADVISED OF THE POSSIBILITY OF SUCH DAMAGES.**

### **III. How to Purchase**

Any eligible individual may purchase as many tickets as he or she or they may wish, up to the maximum number available for sale, but subject to availability, by 11:59 p.m. Pacific Time, October 31, 2023.

Ticket(s) may be purchased one of three ways:

(1) Call **909-386-6929** to place an order by phone, providing name, address, email address, and phone number along with credit card number, credit card security code and expiration date. Phone lines will be open Monday through Friday from 8:00 a.m. to 5:00 p.m. Pacific Time. All major credit cards are accepted; (2) FAX the completed ticket order form available at public displays and [Istream.org/raffle](http://Istream.org/raffle) to 909-381-2036; OR (3) Mail the completed ticket order form available at public displays and [Istream.org/raffle](http://Istream.org/raffle) with payment to The LifeStream Dream Raffle, 384 West Orange Show Road, San Bernardino, CA 92408.

All Ticket phone orders must be placed, and all Ticket order forms must be faxed or mailed, from within the state of California. All orders must include payment by check, cashier's check, money order, or credit card. **Tickets cannot be purchased through the Dream Raffle website, the LifeStream website, or by email.** Any ticket order form submitted by email or on any website will be rejected. No refunds will be made except under the following circumstances: a ticket order with payment received after the 1,000 raffle tickets have been sold or a ticket order with payment is received after October 31, 2023 (even if mailed on or prior to October 31, 2023). No other refunds are available except at the exclusive discretion of LifeStream. LifeStream assumes no responsibility for lost, late, misdirected or non-delivered packages or fax messages, or any other failure to receive orders or deliver receipts prior to the drawing deadlines.

### **IV. Selection of Drawing Winners:**

The LifeStream Dream Raffle drawings will be held on November 11, 2023 from all eligible raffle tickets. The drawings will be held under the supervision of an independent auditor. Winners need not be present to win. The list of winners will be posted on [www.Istream.org/raffle](http://www.Istream.org/raffle) and may also be obtained by sending a self-addressed, stamped envelope to The LifeStream Dream Raffle Winners List, 384 West Orange Show Road, San Bernardino, CA 92408 within 30 days of the drawing.

Winners will be notified through the contact information provided to LifeStream at the time of the ticket purchase. In order to collect his or her or their prize, a winner may be required to sign and deliver to LifeStream: (a) a sworn affidavit of eligibility in accordance with these Rules and applicable law, including, without limitation, that he or she is at least 18 years old; (b) such written information as is required by any applicable tax and/or other applicable laws, including, without limitation, his or her Social Security

Number; and (c) proof of identity in forms satisfactory to LifeStream showing that the person claiming the prize is the same person who is named on the winning raffle ticket. An official ticket stub is not required to claim a prize and is not a substitute for proof of identification. Winners of prizes valued at \$1,500 or more may be required to submit a W-2G, Form 5754 or similar tax form for tax withholding purposes. Please note that the requested information will be mailed and must be sent to a home or business address in California (P.O. Boxes not accepted).

#### **V. Winning Odds:**

Three (3) prizes (including the Grand Prize) will be awarded in The LifeStream Dream Raffle drawing. Any number of raffle prizes above that number is at the sole discretion of LifeStream. The odds of winning a raffle prize will depend on the actual number of tickets sold. If all 1,000 raffle tickets are sold and 3 prizes are awarded, the odds of winning a prize for any given ticket are approximately 1 in 334.

#### **VI. Eligibility**

The raffle is open to any individual who is 18 years of age or older and in the state of California at the time of ticket purchase. LifeStream Blood Bank employees, members of the Board of Directors, authorized agents, consultants, attorneys and employees of the independent auditor are excluded from participating and are not eligible to win a prize. All federal, state, and local laws and regulations apply. The raffle is void where prohibited or restricted by law. An affidavit of eligibility may be required of prize winners.

#### **VII. Raffle Prizes**

The Grand Prize will be a 2023 Ford Bronco Base model factory equipped valued at approximately \$32,000 or a one-time lump sum cash payment of \$25,000 cash, at Winner's election, **if 1,000 raffle tickets are sold. If less than 1,000 raffle tickets have been sold, the Grand Prize will be \$15,000 cash.** The 2023 Ford Bronco Sport Base model will be awarded through LifeStream's partnership agreement with Palms Springs Motors of Cathedral City, California. Cash prizes will be paid by bank or cashier's check to the winning ticket holder. The first raffle ticket to be drawn will win the Grand Prize. The Grand Prize Winner must make the prize selection in writing between the 2023 Ford Bronco Sport and the lump sum cash payment no later than November 30, 2023 at 5:00 pm Pacific Time. If no selection is made by the winner by that deadline, the Grand Prize will become the cash alternative. The Grand Prize (whether the vehicle or the cash payment) does not include sales or income taxes; license, title, and registration fees; delivery or transportation costs; or any other costs associated with the winning and use of the Grand Prize. The Grand Prize is nontransferable and non-refundable and must be accepted as awarded in "as-is, where-is, with all faults" condition. If the Grand Prize Winner chooses the 2023 Ford Bronco Sport, they will be solely responsible for all applicable state, federal and local sales and income taxes and any other taxes associated with the winning and use of the Grand Prize; all license, title, and registration fees; all delivery or transportation costs; and any other costs associated with the winning and use of the Grand Prize, as well as insurance (proof of which must be shown prior to delivery) and pickup or delivery costs at the dealership as well as any non-standard features, option or upgrades chosen by the Winner and negotiated with the dealership. 31, 2024. Prizes not picked up by this date will be considered forfeited and become the property of LifeStream Blood Bank. Prizes awarded via gift cards or gift certificates may be mailed via FedEx or UPS to the address provided at the time of purchase at a winner's request, but LifeStream shall have no liability for any lost, late, misdirected or non-delivered packages. Delivery date, and color, of the 2023 Ford Bronco Sport is subject to availability at Palm Springs Motors. The 2023 Ford Bronco Sport shall be delivered to the winner at Palm Springs Motors of Cathedral City, California.

All taxes, gratuities, and fees are the responsibility of winners.

With respect to any vacation travel prizes, such travel is transferable subject to such person agreeing to be bound by all terms herein. Registration does not imply endorsement.
